 - A shelter was opened during the evening of the shooting for workers. Counselors were on site.
 - Hotel rooms were made available for affected families due to the police investigation.
 - \$1000 for each family was made available for aid during the crisis.
 - One social worker per family was provided with an intent of wrap around support.
 - There is a HMB straw fund for donations. This can be found on the MCC web site.
 - The district attorney announced he is going to be conducting an investigation of those work sites.

 - The county continues with the post storm cleanup process.
 - An SMC alert went out.
 - FEMA has been to San Mateo Co. to access the damage.
 - The Coastal resilience project was discussed.
 - A new fire map is being developed
 - A program is being developed to help homeowners regain fire insurance.
