## Notes from Board of Supervisors meeting 3/28/2023

The Board began the meeting with member comments. It was reported that at the Bay Area Air Management Board by 2027 Gas water heaters will be banned and by 2029 gas heating systems will be banned. Agenda items 1-10 were covered in public the remaining agenda items 11-49 were done in closed session. Agenda item #:

1. Resolution honoring Peggy Jensen for 34 years of service to the county with her last position as Assistant County Manager. She is now retired.

2. Farm worker Awareness Week proclaimed for March 25th-31st. PUENTE, ALAS and Coastside Hope joined with organizations across the country honoring farm workers and the farmworker movement. 3. Chris DeCardy was honored for his service to the county with his expertise in environmental protection policies working in Menlo Park.

4. An agreement for \$8,219,336 was reached with Vituity which will provide emergency medical and correctional health services from April 1, 2023 to March 31, 2026.

5. Child care ordinance and Zoning regulations were adopted to streamline the permitting process for child care centers after concerns expressed by Supervisors Mueller, Pine, Canepa and Slocum. They took issue with the Coastal Commission requirement to require a Coastal Development permit for the conversion of a single family residence to a child care center and certification from the Coastal Commission to protect coastal resources such as environmentally sensitive habitat areas, views and minimize hazards. Supervisor Mueller didn't want anything to slow down the production of new child care centers stating the lack of affordable day care on the Coast. He didn't understand how additional traffic would impact single family home neighborhoods. He suggested pushing back against the Coastal Commission and questioned their relevance. The other board members agreed with Supervisor Corzo suggesting that the Commission come and present to the board. Ultimately they agreed to the zoning regulations as amended by the Coastal Commission.

6. County's Annual Progress Report for 2014-2022 Housing Element and how well the county met 2014-2022 Regional Housing Needs Allocation. The county is short 42 units of very low income housing. There is no penalty for this but it will be added to future housing allocations. Only permitted developments are considered when meeting housing unit requirements. Potential sites in Belmont and Colma were mentioned.

7. Public Works entered agreements with SBAY Construction, Inc, Half Moon Bay Grading and Paving, Inc and Granite Rock Company for engineering, construction, roads and utilities for March 28, 2023 through March 27, 2024 for amounts up to \$5,000,000 each.

8. Approved Grant agreement with San Mateo County Office of Education to develop a pilot project to encourage individuals to enter early childhood education careers and to provide training \$200,000 was authorized. An addition of \$100,000 Measure K funds was also authorized.

9. A resolution expressing appreciation for essential employees who have disabilities or visually impaired was approved.

10. Measure K funds in the amount of \$25,000 was issued for a mural on the bridge connecting Maggie Correctional Facility and Hall of Justice in Redwood City
