# Minutes for Meeting of October 25, 2023

## (7:00pm) Call to Order

- 3. **Mirada Bridge Ribbon Cutting** will be held on November 3<sub>rd</sub>, 1:30 PM at the Mirada Bridge
- 4. Enforcement Removes Guns from People Under Restraining Orders

- The County provided an update on a targeted effort to get firearms out of the hands of people with domestic-violence, gun-violence and certain other civil restraining orders against them.
- A total of 168 firearms 67 rifles or shotguns and 101 handguns were surrendered to law enforcement or federal firearms licensed dealers in compliance with court orders.
- The Gun Violence Prevention Program targets a gap in California's efforts to reduce gun violence: while many laws are on the books, little funding often goes toward enforcement.
- The Board of Supervisors in October 2022 pledged \$2 million over two years to launch the local effort.

- The cleared portions of the the road will take 5-10 years to self restore
- No excuse to remove more vegetation than the 12 foot portion of the road.
- Need for a professional botanist to look at the cut areas to access the damage and restore the damage.
- Keep out invasive species.
- The Butterfly population will decrease.

 The proliferation of invasive species is temporary and the ecosystem will recover.
