Minutes for Meeting of November 29, 2023

(7:00pm) Call to Order

1. (7:10pm) Board of Supervisors report and reports from other government officials

A. **Mike O'Neill, Community Liaison to Supervisor Mueller**, reported on the following items:

Don Horsley, Former San Mateo County Sheriff, Supervisor, Dies at 80

- A former teacher and beat cop whose ideas for reform propelled him to San Mateo County Sheriff and the Board of Supervisors, Horsley passed away last Friday.
- Horsley served 14 years as sheriff and 12 years as a member of the Board of Supervisors. His impact was tremendous and our office is grateful for all the community members who have reached out offering well wishes for his family.
- Information about services is pending.

Gun Buyback Set for Dec. 9 in Belmont

- The County and partners are holding an anonymous gun buyback on Saturday, Dec.9, at 400 Harbor Blvd.Belmont.
- From 10 a.m. to 2 p.m, law enforcement officers will accept all guns, no questions asked, in exchange for cash: \$50 for nonfunctioning firearms; \$100 for handguns, shotguns or rifles; \$200 for assault weapons as classified by the state of California.
- To those planning to attend, transport firearms unloaded and in the trunk of your vehicle.

Sawyer Camp Segment Now Open; Ralston Bike Trail Reopens Dec. 1

- The 6-mile-long Sawyer Camp segment of the Crystal Springs Regional Trail reopened Friday, Nov. 24, after the months-long closure due to storm damage earlier this year.
- Repairs that have been ongoing for several months concluded with the restoration of a 25 foot wide collapsed portion of the trail.
- Ralston Bike Trail, a connector trail to Crystal Springs Regional Trail, is scheduled to reopen Friday, Dec. 1, when PG&E concludes work on the natural gas line in the area.

Flu, COVID-19 and RSV With respiratory virus season upon us, County Health and the Association of Bay Area Health Officials encourages everyone to take steps to prevent flu, RSV and COVID-19.

- Stay up to date on vaccines. Vaccines are the best defense against severe illness and death —and you can get all at the same time. Visit MyTurn to schedule vaccines or contact your healthcare provider.
- Flu and COVID-19 vaccines are available for everyone 6 months and older and have been updated to protect against new variants.
- RSV immunizations are now available for infants and young children, pregnant people and adults 60 years and older.
- Stay home if you're sick. Staying home when you're sick slows the spread of flu, COVID-19, RSV and even the common cold.

- Test and treat. Test for COVID-19 and flu if you have symptoms. If you test positive, contact your health care provider and ask about prescription treatments.
- Consider wearing a mask. Masks can slow the spread of respiratory viruses. If you or your family member are at high risk for severe illness, consider wearing a mask, especially in public indoor or crowded spaces. See more from the California Department of Public Health.

Don't Pack a Pest During the Holidays

- The San Mateo County Department of Agriculture Weights and Measures asks residents to not transport fresh fruits and vegetables from the following fruit fly quarantine zone counties: Los Angeles, Ventura, Sacramento, Riverside, San Bernardino, Contra Costa, and Santa Clara.
- Personal travel is one of the primary avenues for the spread of damaging invasive species and all residents are urged to adopt the principles of "Don't Pack a Pest" to help prevent future introductions of invasive pests and diseases.
- Maps, quarantine restrictions and other information are available.
- If you have questions about a fruit fly quarantine/eradication, or if you think you have fruits and vegetables infested with fruit fly larvae, call the CDFA Exotic Pest Hotline at 1-800-491-1899 or the San Mateo County Agricultural Commissioner's Office at 650-363-4700.

- Mike O'Neil responded by saying that a consultant has been hired to plan an evacuation route.

Patrick Tierney:

- Recommended that the new bridge at Medio Creek be dedicated to Don Horsley

- Asked for an update on the community fiber network

- Asked for an update and a link to the streetscape project on Main Street HMB.

Public Comment:

Fran Pollard:

- Thanks for the vote on the off leash policy and increased signs in Quarry Park.

4. Regular Agenda

a. Medio Bridge Update. Assessment of damage reports. **Speaker: Krzysztof Lisaj, DPW** presented information on bridge construction and possible erosion control plans and maintenance.

Comment:

Patrick Tierney:

- Concerns on the southern wall erosion.
- Replace rip rap.

Burnett Silveria

- Erosion concerns.

Carlyle Ann Young:

- Trash receptacles at the bridge are overflowing.

Dan Haggerty:

- North side wall looks unfinished.

Kimberly Williams:

- We should not be surprised by erosion.
- What is the cost of ongoing maintenance?
- What was the final cost? *\$3.5 Million*
- Look into alternatives for moving the trail in the future.

Claire Toutant:

- Where will the bridge be moved in the future?

Michelle Dragony:

- There is currently a lawsuit between the County and the Condo on the south side of the bridge.

b. (8:30) Montara Mountain Preservation.

- The council had a discussion regarding the trip up Montara mountain hosted by the State Parks department.
- A letter concerning the trip was reviewed.
- **The frequency of trips on the trail to the towers for propane delivery and maintenance needs to be determined.**

c. (9:00) Managing Midcoast Priorities. Update on MCC requests and desired process for working with the County.

Gregg Dieguez:

- Mike O'Neil has limited availability.
- There is a need for a general manager for the Midcoast.
- The "Ask" should be for a permanent staff member.

Dan Haggerty:

- Not in favor of hiring staff for the MidCoast.

Gus Mattammal:

- Interested in finding more details on the Fair Oaks Community.

Kimberly Williams:

- What is the status of Mike O'Neil in the future?
- Request an MCC liaison to the County.
- Want to not lose independence of the council.

Ann Rothman:

- Ann is in support of a clerical position.

Len Ericson:

- Asked for more information on the position.
- *Gregg replied: researching potential job description and what North Fair Oaks has.*

Carlyle Ann Young:

- Made a request for a new representative to the County who will lobby on our behalf, rather than requiring residents to do the legwork.

Burnett Silveria:

- What is status of new communications protocol between MCC and the County?
- *Gregg replied: subgroup on Managing Midcoast should address*
- *Scott: suggested laying out job duties for scoping the workload.*
- *Dan: perceives danger in loss of control of a new County resource.*
- *Kimberly: if MCC hires the staff, less concern about loss of control.*
