### **Surfers Beach - Maintenance & Repair**

Email from Sheryl Sablan (Caltrans – Office Chief Division of Maintenance)

- We are currently going through the process of obtaining information from our contractor for the stairs at Surfer Beach. We are hopeful that we can begin work in the first half of 2024. We will need to submit permit applications for this project and the start of construction will be dependent on when we do receive our permits.

### **Surfer's Beach – Temporary CDP - Coastal Trail and Armoring**

From Zachary Gifford (CaltransRE: Surfer's Beach CDP and the specific condition that requires Caltrans to find a long term solution. This is found in the CDP in Special Condition 9 on page 6, Special Condition 8, also on page 6, is the condition that states the time period the RSP is authorized for at Surfer's Beach. The current authorization is for 10 years with the possibility of an additional 5-year extension. The initial 10-year period is up in June 2025. We want to start developing a long-term strategy for this corridor and needed to start somewhere. So, Caltrans is developing a feasibility planning study of this area, we are calling it for now Surfer's Beach Long Term Planning and Feasibility Study.

The study will review available data and studies conducted at the project site to help identify adaptation opportunities. It will identify an initial list of potential shoreline protection scenarios to consider in this coastal assessment, analysis of shoreline and bluff erosion data, as well as looking at wave overtopping and flooding analysis and modeling.
